

Checklist

Settlement Permit

The settlement permit is an unlimited residence permit and entitles to carry out any gainful activity.

Guidance for meeting the requirements (§ 9 Abs. 2 AufenthG):

1. you have held a valid residence permit for at least five years (half of previous training and study periods are taken into account)
2. you have acquired entitlement to benefits for adequate retirement provision: At least 60 months compulsory contributions or voluntary contributions to statutory pension insurance or comparable benefits
3. you have sufficient knowledge of German (B 1)
4. you meet the requirements for the extension of your current residence permit

Differing conditions apply as follows (not conclusive):

A. Family member of a German citizen (§ 28 Abs. 2 AufenthG):

- After 3 years with sufficient German language skills (B 1)
- the family relationship with the spouse, child or parent with the German citizen in Germany must continue

B. Skilled employment with recognised training/ degree and researchers (§§ 18a, 18b or 18d AufenthG):

- more than 48 months of qualified employment and sufficient knowledge of German (B 1)

C. Graduates of German universities or apprenticeships (§18 c Abs. 1 S. 2 AufenthG):

- At least 24 months of skilled employment
- for German-language studies/ apprenticeships , the proof of German language skills is not required.

The following documents are required for the application:

- completed application form*
- passport
- Sufficient pension provision
 - Information on pensions or details on pensions from the Deutsche Rentenversicherung or
 - Proof of entitlement to comparable benefits from another insurance or pension institution
- German language skills
 - Language certificate of a certified language course provider (telc, Goethe Institut, ÖSD)
 - Certificates for integration course (if available)
- Proof of continuous sufficient health insurance coverage
 - With a statutory health insurance: Current insurance confirmation
 - In the case of private health insurance: confirmation of Annex 5 by the health insurance*
- Rental agreement with details of the current rental costs and the size of the apartment
- Proof of income:
 - Family reunification: Statement of earnings for the last three months of family members living in a household
 - Freelance work: current profit calculation by the tax consultant using the form Information on gross/net income* and orders / contracts with several clients (if available)
- German university degree (if applicable)

Information for the application:

To apply for a residence permit, please contact the Hamburg District Foreigners Office responsible for your place of residence or the Hamburg Welcome Center (HWC). If you are staying in Germany for the purpose of family reunification, you can apply at the HWC if the person with whom you are reuniting is in gainful employment and, as an employee or freelancer, achieves an income of more than 43,056 euros (value limit section 18 b paragraph 2 sentence 2 of the Residence Act).

To determine the responsible district office, proceed as follows:

1. Call up the Hamburg Administration Guide (Behördenfinder): www.hamburg.de/behoerdenfinder
2. In the "Suchbegriff" field, enter the term "Ausländerangelegenheiten" and select "Suchen"
3. Enter the registration address in Hamburg (street and house number)
4. Select the red button "Weiter"

The Hamburg Administration Guide will show you the relevant department's contact details and opening hours.
